Assumption of Risk

Events may include but are not limited to team sports, hiking, swimming, low and high ropes course activities, and tomahawk throwing.

Medical Emergency

In the event of injury or a medical emergency, I understand that my group's leader, not Vision Ministry, will be responsible for the medical care of all attendees.
